Training Course

This is a course for Learners who will be responsible for developing traffic management plans (TMP) and traffic guidance schemes (TGSs) on urban streets and low volume rural roads (Category 1).

Bring your own device. A laptop and charger is required to conduct in course and post course assessment activities.

Post Course – to be completed within 6 months

Learners are required to complete the traffic management designs started in the training course and complete another traffic management design (TMP and associated TGSs) in the workplace.

It is highly recommended that you have access to the TMP design software being used in your workplace.

Examples of TMP design software includes; Rapid Plan, Auto Cad, Road Manager, Corel Draw, MS Paint, Google Draw.

Course Content

- Plan and implement risk management processes including identifying hazards and developing risk controls
- Auditing the risk management process and completing records
- Establish context for traffic management plan and traffic guidance scheme
- Prepare traffic management plan and associated traffic guidance schemes
- Review traffic management plan implementation

Learner Requirements

- Ability to read, write, speak and understand English
- Learners must be at least 18 years of age
- **Learners are required to be reaccredited every 3 years**
- Learners must provide evidence of completing either of the following options:
 - **Option 1:** Any of the following:
 - * RIISS00060 Traffic Management Implementer Skill Set for Urban Streets and Low Volume Roads; OR
 - * RIISS00061 Traffic Management Implementer Skill Set for High Volume Roads; OR
 - * RIISS00062 Traffic Management Implementer Skill Set for Motorways and Freeways
 - AND** At least 12 months experience applying the Skill Set skills and knowledge in a temporary traffic management workplace
 - AND** Provide evidence of relevant experience setting up at least 20 temporary traffic management types in at least four of the following design types
 - ♦ pedestrian and cyclist controls
 - ♦ construction sites
 - ♦ lane closures
 - ♦ night works
 - ♦ shoulder closures
 - ♦ use of portable traffic control devices
 - ♦ motorways or freeways.
 - **Option 2:** For existing Designers, **only during the Jurisdiction's transition phase** to the TTM National Training Framework (until Feb 2027):
 - * Must be currently permitted in their jurisdiction to develop, review or audit traffic management designs or traffic guidance schemes **AND**;
 - * Must provide evidence of currency of practice, from last 3 years, of designing, reviewing or auditing one of the following:
 - ♦ 12 traffic management plans (TMPs)
 - ♦ 12 traffic guidance schemes (TGSs)
- **Option 3:** At least an AQF Level 6 qualification in a civil construction, traffic engineering or road design related field

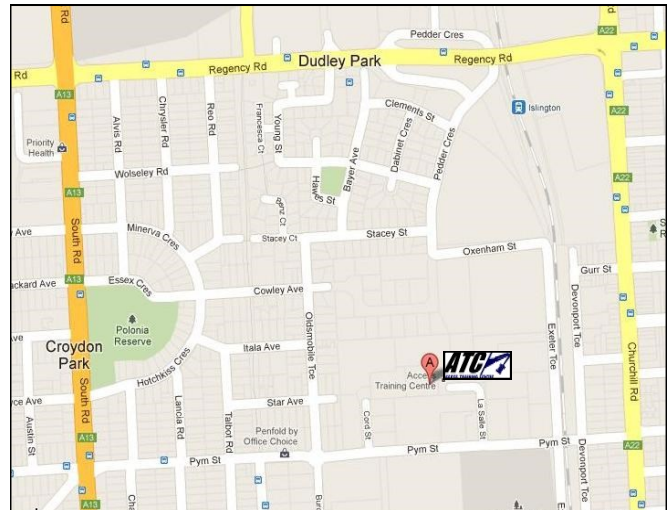
